## 2022 OHIO STATE FAIR GOLF CART APPLICATION

The use of Golf Carts during the Ohio State Fair is limited to special circumstances where a need has been demonstrated, and only when an Ohio State Fair Golf Cart Permit has been issued. Golf Cart Permit Applications must be completed and submitted by **July 1, 2022**. The Golf Cart Application is subject to review. Submission of this application does not guarantee a golf cart permit will be issued.

- All approved golf carts will be issued a permit. This permit must be prominently displayed on the golf cart at all times during the Fair.
- **There is a non-refundable permit fee of \$200.00.**
- All golf carts must be registered with the Fiscal Office by completing the Golf Cart Application.
- **No application will be reviewed unless a copy of auto liability insurance and a copy of approved operator's driver's license(s) is submitted with the application. Attach Copy of Driver's License for Each Operator.**
- Golf carts can be operated **ONLY by a pre-approved, licensed driver**. Golf carts can be driven ONLY on the blue line.
- Any Permit holder found in violation of any policy pertaining to golf cart use will automatically forfeit their golf cart permit as well as be subject to golf cart confiscation by the State Highway Patrol. The golf cart will be confiscated and the owner must remove the cart from the fair no later than midnight on the day of the impoundment. Owner/applicant will be held responsible.

## **RULES FOR USE OF GOLF CARTS DURING THE 2022 OHIO STATE FAIR**

- ▶ A 2022 permit must be attached to the front of the cart AND REMAIN CLEARLY VISIBLE AT ALL TIMES.
- ▶ Between 10:00am and midnight, carts are allowed on the blue golf cart route only as indicated by the dotted line on the included map. This path is designed with the safety of the fairgoer in mind.
- ▶ Carts must be kept secure at all times, especially at night.
- ▶ Drivers must be 16 years or older and have a valid driver's license.
- ▶ Carts must be operated in a safe manner and ONLY BY PRE-APPROVED, LICENSED DRIVERS.
- ▶ Drivers and passengers are not allowed to consume alcoholic beverages on carts.
- ▶ Golf cart speed limit is 10 mph.
- ▶ Having more individuals in a golf cart or side-by-side than seats in the vehicle is strictly prohibited.
- ▶ Carts are for official use only. No joyriding or racing will be allowed.
- ▶ When parking your cart, be careful to avoid blocking access to concessions, walkways, or roadways.
- ▶ Carts are not permitted on the grassy areas of the grounds.
- ▶ Cart rules apply to dates starting Monday, July 11 and ending Sunday, August 7.
